Discussion:

-Because of the mild winter, there is an excess of \$12,000 that will be put into a contingency fund for

future use. All that was budgeted for snow removal, roof raking and roof heating coils was not

-An expenditure of \$79,000 was made for the new roof on Building 35.

- Six chimneys and crickets on the duplexes is budgeted to cost \$29,000
- Any skylights that are leaking prior to the roof replacements will be repaired by the association using funds in the operating budget.
- -In response to questions about the cost of the sewer project, it was stressed that our cost for our project will be kept separate from those of the Lakeview Condominiums.
- -Both operating and capital expenses in the 2017 Budget will be covered by monthly fees. A 3% raise in fees will bring monthly fees next year to \$451 per month per unit.
- -In addition to the money paid to Pathways for Sewer work next year, \$6,500 has been budgeted for drainage work to also be done by Pathways.
- -A final budget for 2017 will be sent to owners in December.
- -The Board will continue to work on the budget and a final proposed budget will be sent to owners in December of this year.

Boards Annual Report:

President Sandy Orr gave a summary of the Board of Directors Report and then opened the floor to questions and discussion. Focus was given to work done with Pathways to hitch up sewer to Enfield town sewer system., replacement of Triplex roof and repair of Duplex roofs and in addition to regular maintenance.

Ray explained a proposed change to the SLCA Declaration (Seventh Amendment) that would allow for the conversion of common area to limited common area with Board approval.
